DECLARATION OF AWARENESS, LIABILITY AND JOINT LIABILITY

Bovec Rafting Team, Adis Hrovat s.p., Mala vas 106, 5230 Bovec (hereinafter: BRT) organises and leads the following activities: rafting, mini-rafting, kayaking and kayak school, hydrospeed/river bob, canyoneering, night/day canoeing or mini-rafting by night or day, adrenaline park, cycling, hiking, sport climbing, abseiling, team building programmes, caving, parachuting, and skiing programmes and ski school.

For the activities it organises and leads, BRT provides leaders, safety equipment, transport to and from the activity, and liability insurance.

If an activity is cancelled before it starts, BRT will refund 100% of the money paid. If an activity is interrupted once it has started, BRT will not offer a refund.

- I the undersigned declare that I am aware that the activity in which I have knowingly and voluntarily agreed to take part is an activity involving an increased level of danger and therefore, in the case of accident, it should be taken into account that I have knowingly accepted this risk. Since BRT cannot guarantee absolute safety while the activity is under way, in the case of accident or mishap during the activity I accept joint liability.
- The period of duration of the activity shall be considered to be everything that happens from the moment the guest enters BRT's business premises until the guest returns from one of the activities listed above and departs BRT's business premises.
- In the case of injury during the activity, I shall provide all necessary personal details to the responsible persons at BRT. I shall report all injuries occurring during an activity to BRT, and together with BRT make a report which I shall also sign. In the case of accident I consent to be accompanied to a doctor by a representative of BRT.
- I am aware that safety always comes first, and therefore I will follow the instructions of leaders and other BRT staff.
- I respect the fact that BRT does not allow guests under the influence of alcohol or other intoxicating substances to take part in activities. I confirm that I am not under the influence of alcohol or other intoxicating substances.
- I confirm that I can swim.
- I am aware that BRT does not advise participation in activities for pregnant women and heart patients.
- I am aware that those suffering from epilepsy, asthma and other health problems must consult the leaders before the activity.
- I am aware that in the case of various prior physical injuries I must consult the leaders before the activity.
- I am aware that BRT does not accept responsibility for lost or damaged personal items.
- I am aware that BRT photographs guests before, during and after activities. I
 give my consent to be photographed, and for the photographs to be used for
 BRT promotional purposes (internet, brochures and leaflets, poster, etc.). I

agree that photographs taken before, during and after activities are the property of BRT.
